PSYCH AB/NEG	4	This is calculated and is the number of referrals involving psychological abuse/neglect on RRD2. There are five tallies to track reported, substantiated, unsubstantiated, indicated, and other. The following allegation codes are included: PSA, EMA, EMN, EAN.
SEXUAL ABUSE	4	This is calculated and is the number of referrals involving sexual abuse on RRD2. There are five tallies to track reported, substantiated, unsubstantiated, indicated, and other. The following allegation codes are included: CSE, SAI, SAS, SAT, SEC.
NEGLECT/DEPRIVATION	4	This is calculated and is the number of referrals involving neglect by deprivation on RRD2. There are five tallies to track reported, substantiated, unsubstantiated, indicated, and other. The following allegation codes are included: PHN, EUR, ABA, FTT.
MEDICAL NEG	4	This is calculated and is the number of referrals involving medical neglect on RRD2. There are five tallies to track reported, substantiated, unsubstantiated, indicated, and other. The following allegation codes are included: MDN, BDM.
