Report Summary

This report extracts open placements on PLAD and sorts the placements by region and then by county. It adds up all the county placements that have the drug code indicator set to ‘N’, adds up all the county placements with the drug code indicator set to ‘Y’ and gives the percentage of county placements that were caused by drug use within the county. The report also tallies the type of drugs that caused the placement within the county and the percentages of the use of each drug within the county. Every time the county changes a new report is printed. If the county does not have an open placement to report, no report is printed.

Report Purpose

To show, per county, the percentages of placements caused by parental or caretaker drug use.
