Report Summary

Summarizes the number of kids over age 17 in an open foster care placement with an active eligibility on the eligibility screen that falls within one of the following fund types: IVE ONLY; IVE & IVA; IVE, IVA & TXX; IVA ONLY; IVA & TXX; TXX ONLY; GFO ONLY for the reported calendar month. Breaks the data into region (based on CAPS financial county) totals by fund source type (from the eligibility screen (CELL)) and provides totals.

Report Period

The report period is for the prior month.

Criteria for Extracting Data

- The placement must be a foster care (F) placement
- The placement must fall within the reported calendar month
- The client must be over age 17
- Either the assigned worker or a shared worker must be a DPHHS worker
- The eligibility must fall within the reported calendar month
- A total will be displayed under a particular eligibility type if and only if a client in the region has an open placement and eligibility from one of the eligibility types during the report period
- One client may be counted under more than one eligibility type
