Field Descriptions (F12) indicates code lookup is available.

CAPS ID

This field will display the CAPS ID of the client that was entered on the SIID (SEARCHS Initial Inquiry Detail) screen.

NAME

This field will display the name of the client whose CAPS ID is entered in the CAPS ID field.

MOTHER

This field will display the name of the mother. This defaults from the RELL (Relationship List) screen.

MAIDEN

This field will display the maiden name of the mother. This defaults from the AKAD (Person name AKA Detail) screen.

MOTHER'S GOOD CAUSE REASON(S) (F12)

Enter if good cause exists to not pursue child support or if no good cause exists.

APPROVED

This field will default to “A” (approved) if “no good cause exists” is selected in the GOOD CAUSE REASON field. If “good cause exists” is selected in the GOOD CAUSE REASON field, the supervisor must approve. *An alert will be sent to the assigned worker’s supervisor that good cause reason must be approved.*

BY

This field will display the C number of the worker who approved the good cause reason.

DATE

This field will display the date the good cause reason was approved.

PROVIDE ANY INFORMATION YOU CAN ABOUT THE FATHER’S SITUATION

This is a free-form text area to enter any additional information about the father that you think is important for the child support worker to know.

OTHER COMMENTS

This is a free-form text area for you to provide any additional comments.

Additional Information

If you enter “good cause exists”, the reason(s) must be re-evaluated every six months to ensure it is still a valid good cause. An alert will be sent to the assigned worker and the regional fiscal officer.
